_____ I agree to keep all vaccinations current including, but not limited to, Rabies, Distemper/Parvo (DHLLP) and ensure the dog receives preventative medication to protect against heartworm disease. In addition, I agree to provide the best available care to the dog in a timely manner.

Dogs for Better Lives has financial assistance available to help with veterinary expenses for dogs we have placed. This assistance is available in cases of out of the ordinary expenses that cause financial hardship and where the prognosis for recovery is good.

There are certain additional requirements, and there is no guarantee of approval for reimbursement, as each request is evaluated individually.

PLACEMENT

_____ I understand that the Dogs for Better Lives Obedience Trainer and Adoption Program Coordinator will bring the dog to my home for placement. If it is determined that the dog and I are not a good match, the placement will not take place.

_____ I understand that it takes at least three weeks for a newly adopted dog to settle into his/her new home environment and agree to work closely with the Obedience Trainer and Adoption Program Coordinator to make the placement of my new dog successful.

FOLLOW-UP

_____ I understand that I will receive a follow-up phone call from a Dogs for Better Lives Obedience Trainer or the Adoption Program Coordinator within four (4) days of placement. This is to ensure the placement is going well and to schedule times for Dogs for Better Lives to visit my home to work on any obedience or behavioral issues, as needed.

_____ I understand and agree that a follow-up visit from an Obedience Trainer or the Adoption Program Coordinator will take place within seven to ten days of the adoption.

_____ I understand and agree that additional follow-up visits may be scheduled to work on any obedience or behavioral issues as determined by Dogs for Better Lives

OBEDIENCE TRAINING

_____ I understand that Dogs for Better Lives provides ongoing obedience training and support for the lifetime of the placement.

_____ I understand it is my responsibility to contact the Adoption Program Coordinator at the **onset** of any concerns, questions I have, or behaviors my dog is displaying and agree to work with the Dogs for Better Lives Obedience Trainer to resolve them.

BEHAVIORAL ISSUES

(I.E: biting, prey drive, destruction, digging, escapism, fearfulness, dominance, housetraining, etc.)

_____ I agree to contact the Obedience Trainer or Adoption Program Coordinator regarding any obedience or behavioral issues at the *onset* of the behavior and to follow the recommendations given to resolve the issue(s) in an effort to maintain custody of the dog.

PUBLIC ACCESS RIGHTS

Adoptable Dogs are pets and do NOT have any special rights. They are not, nor are they suited to be, Service, Assistance, Companion, PTSD, or Therapy Dogs.

_____ I understand that I do not have the right to enlist the dog that Dogs for Better Lives may place with me into Service, Assistance, Companion, PTSD, or Therapy Dog training.

_____ I understand that the dog does not have legal access rights and that I may not take the dog that Dogs for Better Lives may place with me into public places that only Assistance or Service Dogs are allowed.

_____ I understand that Adoptable Dogs are only allowed in places where pets are normally allowed.

_____ I agree to neither attempt to exercise legal access rights, nor represent to others that I have such access rights.

RIGHT TO RECLAIM

_____ I understand and agree that Dogs for Better Lives reserves the right to reclaim the adopted dog if any of the above conditions are not met.

RELEASE AND INDEMNIFICATION/NO LIABILITY

_____ I hereby release Dogs for the Deaf, Inc. dba Dogs for Better Lives from any & all liability for personal injury, property damage, legal fees, veterinary care, or any other expense or liability incurred by me as a result of this adoption.

_____ I agree to indemnify Dogs for the Deaf, Inc. dba Dogs for Better Lives from any and all such claims.

Dogs for Better Lives reserves the right to remove any dog that we have placed with you from your home if the dog is being neglected or abused, if the environment is not appropriate for the dog, if you attempt to take your dog into public places that only a certified Assistance or Service Dog is allowed (legal access rights), or represent to others that you have such access rights.
