DOGS MEETING SPECIFIC CRITERIA ARE BROUGHT TO DBL'S SOUTHERN OREGON CAMPUS FOR FURTHER EVALUATION AND NECESSARY MEDICAL TREATMENT. THEY THEN BEGIN EXTENSIVE TRAINING, WHICH CAN TAKE UP TO 4-6 MONTHS OR LONGER FOR EACH DOG. ONCE TRAINED, DOGS ARE CAREFULLY MATCHED WITH APPLICANTS FROM A WAITING LIST, TRAINERS TAKES THE DOGS TO THE CLIENTS' HOME TO TEACH THEM HOW TO MAINTAIN THE DOG'S TRAINING. THE ORGANIZATION PRESENTS TO SEVERAL DIVERSE AUDIENCES ACROSS THE NATION, DEMONSTRATING HOW THE DOGS ARE TRAINED TO HELP PEOPLE. DBL IS CONTINUING TO DEVELOP ITS VOLUNTEER AMBASSADOR PROGRAM, IN WHICH VOLUNTEERS ARE TRAINED IN PRESENTING TO THE PUBLIC AND INTERVIEWING PROSPECTIVE CLIENTS ON BEHALF OF DBL.
